PARENT NOTIFICATIONS

Osceola Middle School Parent & Family Engagement Plan Summary

In an effort to increase the academic achievement of students, all schools in the District that receive Title I, Part A funding must, involve parents and family members in jointly developing the district plan under section 1112 and developing support and improvement plans under section 1111(d). Involving Parents

Parent Meetings

Meeting will be held no sooner than 6:00pm so parents who have conflicting schedules will be able to attend the meetings. If some parents request morning meetings, then the school will be able to consider that as a possibility. We will also ensure that all the parents who have given their e-mail addresses to the Family Engagement Committee will receive all the notes from the meetings.

Supporting Partnerships

Osceola Middle School will build the capacity for strong Family Engagement by providing access to an open computer lab at the school at least one time per week. Parents are invited to come and use the lab to check Skyward, support academic programs such as i-Ready, or use the computers for personal use. Other parent involvement activities will include academic nights focusing on Reading, Science & Science Fair, and student test scores and standardized tests.

Other Activities

Osceola Middle School will provide parents with information on student achievement, discipline data, and school budgets though PTO and SAC meetings.

Communication

Osceola Middle School will communicate with parents through a variety of techniques. Newsletters will be sent home in both English and Spanish as well as posted on the school website. The school will send out a least one automated phone call and newsletter a month to inform parents of upcoming events. We will also use the Remind application to inform parents of upcoming meetings/events. After each event parents will complete a survey online to give the school feedback and to make any requests or give any suggestions (these surveys will be given on campus after/ during the parent workshop). Information will be provided to parents by newsletter, website, Facebook, and recorded phone calls made via Blackboard Connect. Newsletters and/or Blackboard Connect will be used to provide timely information to parents. The school will monitor that the information was provided through end-of-year climate surveys and parent feedback.

Full Participation in all School Activities

Osceola Middle School will provide opportunities for parental participation through many methods. A member of the Family Engagement Committee is bi-lingual; she will translate as needed during the meetings. All parents will be receiving e-mails/letters and

phone calls regarding all events and meetings dates. All information will be translated into an understandable language for the parent. In the event that a parent with disabilities needs additional assistance, those services will be available at the school upon request.
